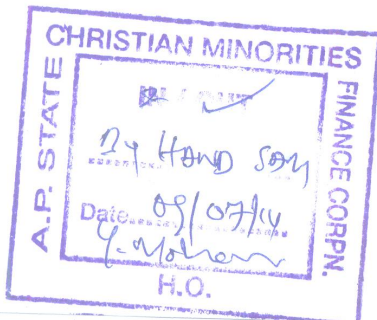

It is submitted that, in the reference 1<sup>st</sup> cited, Government orders were issued creating a dedicated wing and a separate Corporation viz. Andhra Pradesh State Christian Finance Corporation for Christian Minorities to focus on the issues faced by the Christian Community, address them in a time bound manner, coordinate their needs with all other Ministries of the Government and to adequately address the issues pertaining to the Community.

Among the schemes implemented by the AP State Christian Minorities Finance Corporation, few schemes like Youth Awareness Programme, Mass Marriages, Entrepreneur Development Programme, High Tea Programme etc., requires gathering of the Christian Community and are continuous ongoing programmes. In this regard, AP



State Christian Minorities Finance Corporation is spending huge money for hiring the venues for the implementation of the said programmes.

In the reference 2<sup>nd</sup> cited, Government has assigned the scheme of Financial Assistance for the Construction of Community Halls and Youth and Resource centres to APSCMFC.

In the reference 3<sup>rd</sup> cited, the Government in Social Welfare Department has issued the orders for the construction of Ambedkar Bhavans at District Headquarter level for the needs of the Scheduled Caste communities.

In the reference 4<sup>th</sup> cited, the Government has approved a standard type design, model plan and fixed estimates for the construction of the Ambedkar Bhavans and Community Halls.

Therefore, keeping in view the needs of the Christian community such as group gatherings, youth meetings, marriages etc., and the schemes that are being implemented by the Christian Corporation there is a dire need for one Christian Bhavan at District Headquarters.

In view of the above, it is requested to sanction Christian Bhavans in all the 13 districts of Andhra Pradesh and extend the type design model and estimates approved by the Social Welfare Department for Ambedkar Bhavan for Christian Bhavan also and sanction an amount of Rs.13.00 Crores at the rate of Rs.1.00 Crore for each district for construction of Christian Bhavans in all District Head Quarters on similar lines of Ambedkar Bhavan.

All the relevant Government Orders are enclosed for ready reference.
