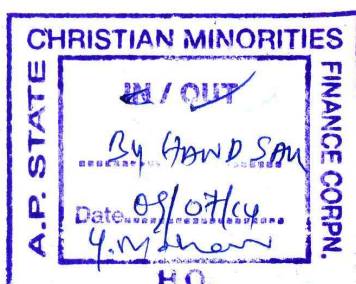

It is submitted that the Post Matric Scholarships to all the BC-C Christian Students is being released through Epass portal.

In the Epass website the income ceiling for BC-C Christian Students has been fixed at Rs.1.00 Lakh only on par with other BC Communities.

In this regard it is submitted in the reference 2<sup>nd</sup> cited, Govt. has issued orders granting all Non-Statutory concessions available to Scheduled castes to BC-C (Scheduled castes converted to Christianity) on the ground that the Scheduled caste converts suffer from all the social disabilities as SC's irrespective of their conversion, hence as per this G.O. the income ceiling of SC's and BC-C candidates should be similar.



It is further submitted that as per reference 1<sup>st</sup> cited, at present for SC students the income ceiling fixed for claiming PMS is Rs.2.00 lakhs, but for BC-C Students Epass has fixed income ceiling of Rs.1.00 Lakh, which is contrary to the G.O issued by the Govt. in the reference 2<sup>nd</sup> cited.

In view of the above it is requested to instruct the Epass to modify the income ceiling of BC-C Christians on par with SC Students to Rs.2.00 Lakhs per annum, since most of the BC-C families are below poverty line and they are doing petty jobs in private sectors and raising the income ceiling would facilitate most of the eligible BC-C students to claim Post Matric scholarships.
